National Statutory Assessments

Attendance remains to be a huge focus nationally and of course within our school. Each term now, we meet with a 'partner' from Lincolnshire County Council whose role is to look at caseloads, offer advice and guidance as to our processes and systems.

At the end of the Autumn term 2023 our attendance data was as follows:

Attendance – 95.1% Persistent Absenteeism – 15%

That means that 15% of children (42 children) have attendance lower than 90%. Please work with us in ensuring that children come to school every day and on time. Late arrivals to school after 9.10 am also count towards the persistent absenteeism percentage. The practical impact though is that children miss out on valuable teaching and learning time. At this time in the morning, every day phonics lessons take place. This is when they learn to read and to write. Any time lost will mean that they might struggle to access the wider learning and their learning journeys.

We take your child's safety very seriously here at Castle Wood Academy and nowadays, this increasingly includes online safety. I felt it may be useful and perhaps give a little peace of mind for parents & carers to outline our online safety systems.

We have robust filtering systems in place to ensure that, while on site, pupils cannot access internet content that is inappropriate. These sites are blocked, preventing access on all school devices and we regularly review this process & add other sites as they become known to us.

Additionally, we monitor internet usage closely. This includes in person, by being vigilant when pupils are using electronic devices in school and also digitally, where we are supported by software which monitors usage & produces reports. These reports are then used to inform us to any further actions that may need to be taken in order to improve our online safety even further.

All of these measures are outlined in more detail in our Filtering & Monitoring Policy, which can be found on our website.
