This template can be used for multiple purposes:

- It enables schools to effectively plan their use of the Primary PE and sport premium
- It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium
- It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make additional and sustainable improvements to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated <u>Primary PE and sport premium guidance</u>.

The Primary PE and sport premium guidance, outlines 5 key priorities that funding should be used towards. It is not



necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards. The priorities are:

- 1. To increase staff confidence, knowledge and skills in teaching PE and sport
- 2. To increase the engagement of **all** pupils in physical activity
- 3. To raise the profile of PE and sport across the school
- 4. To broaden the range of sports and physical activities, pupils receive
- 5. To increase competitive sport participation

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Schools must also outline what the impact this funding has had on pupils' PE and sport participation and attainment and how any spending will be sustainable in the future. **All funding must be spent by 31st July 2025.**

The Department for Education has worked closely with the Association for Physical Education (afPE) and the Youth Sport Trust (YST) to develop this template and encourages schools to use it. This template is an effective way of meeting the reporting requirements of the Primary PE and sport premium.

Develop teaching staff knowledge, skills, competence & confidence in teaching PE.	 Staff have been provided with high quality PE coaching for the last year using Premier Education. The impact of this is that teachers are far more competent to deliver a high quality PE lesson, with strong outcomes and development of skills from the children. Staff have the confidence now to deliver these lessons independently from the input of Premier Education. 	The use of Premier Education over the last two academic years has provided fantastic opportunities for both children and staff. Swimming Data

Meeting National Curriculum requirements for swimming and water safety.

Priority should always be given to ensuring that pupils can perform safe self-rescue even if they do not fully meet the first two requirements of the National Curriculum programme of study

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	80%	With the children attending swimming lesson over year 4 and year 5, the children had two full terms of quality swimming lessons with Everyone Active, where they were able to practice and improve their swimming skills. The data significantly improved over the course of year 5.
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	50%	The children in year 6 have a wide range of abilities in swimming. Although most children can swim on their front, some of the 80% do not have the confidence to swim different strokes.Staff are more focused on the children being safe in the water first, before moving onto being able to swim different strokes. Staff at Everyone Active are committed to children swimming 25m with one strong stroke, rather than challenging them with different strokes that the children find difficult.



What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?	80%	All children that can access the 25m pool were able to complete the safe self-rescue in this pool.

Have you done this?	No	The Sports Premium budget has been used to facilitate the quality of education within the school setting.
Have you provided CPD to improve the knowledge and confidence of staff to be able to teach swimming and water safety?	Yes	Staff developed water safety knowledge through work with the instructors at Everyone Active, specifically during the water safety sessions completed with the children.
